The parties within this agreement agree that:

ShipCon Limassol Limited declares to be available to host 12 participants (students) for 13 days (travel days included) from 05.11.2019 until 18.11.2019, and commits:

- To assure the achievement of the aims promoted by the project;
- To negotiate a customized learning programme for each participant;
- To arrange the monitoring and tutoring condition;
- To assure a constant evaluation of the project course and bring about changes if necessary;
- To favour a comprehension of local culture and habits;
- To assign tasks and duties to the participants in relation with their skills and to the aims of the experience;
